1. BACKGROUND

The Free State National Botanical Garden (FSNBG) has been allocated funds for maintenance of building and infrastructure to keep the standard of the building and infrastructures always high. The Children play area is old and has found to be unsafe and risky to play on and the H&S Deputy Director recommended that, it should be removed completely.

The purpose of this Terms of Reference is to ensure that all interested parties have a clear understanding of the project and would be able to submit quotation based on the same principles.

2. PROJECT SPECIFICATIONS

Objective

To construct and install suitable equipment at the Children's Play Area at the FSNBG.

Location of the construction site

The exact parameters of the site will be outlined at the compulsory site meeting.

Design and Installation

Interested Service Providers are required to submit a comprehensive design of the proposed playground equipment and supply a quotation for both the construction and installation thereof.

The chosen service provider will be required to construct and install the following items:

- Jungle gym (one that consists of different types of swings e.g. rope, tyres, slides, spiral slides and more.

- Two triple swings that consist of a chain and tyre or chain and wooden log
- 2 m² sand pit
- Rubber mat
- 20 x 20 m wooden short fence
- Artificial grass cover for the whole play area
- Two wooden see-saws

IMPORTANT: All materials need to be environmentally friendly and consist mainly of wooden components. All equipment needs to be varnished.

3. General Site Conditions

The procurement and implementation process must be done transparently and in close consultation with the client.

Safety

- The construction site must be completely cordoned off with the necessary safety signs clearly displayed;
