1. BACKGROUND

SANBI seeks to appoint a service provider to provide well composted bark of 12 mm size as well as 6mm in size on the Kirstenbosch National Botanical Garden (NBG) Campus for the period of five 3 years. Bark suppliers within the Western Cape with very good and reputable profile and known bark origins, relevant skills set, and good empowerment profiles are invited to submit proposals to SANBI, to provide well composted bark. The contractor must ensure that it will have sufficient supply of about 22 cubic metres of both sizes within the specifications outlined above. The main aim to have a consistent texture, quality, and quantity as per growing requirements of our display plants at Kirstenbosch.

2. LEGISLATION
