Terms of Reference / Invitation to Quote

The South African National Biodiversity Institute (SANBI) wishes to appoint a Service Provider (individual or team) on an Independent Contractor Agreement to assist with strategic planning for its biodiversity science mandate, particularly relating to future directions for research.

1. Background

SANBI is a public entity in terms of section 38(1)(m) of the Public Finance Management Act (Act 1 of 1999) with functions assigned in the National Environmental Management-Biodiversity Act (NEMBA) of 2004. Key priorities are also derived from official sources that identify issues with a high relevance to policy, such as, the National Biodiversity Strategy and Action Plan (NBSAP), the National Biodiversity Framework (NBF), the National Biodiversity Research and Evidence Strategy, government delivery agreements, and other national priorities (e.g., wildlife trade, the green economy), and specific mandates such as provided by the White Paper on the National Climate Change Response Policy (Table 1 **Error! Reference source not found.**).

The legal and policy framework that determine SANBI's mandate requires the Institute to focus on various science functions including:

- Monitoring and reporting on the status of South Africa's biodiversity
- Co-ordinating and promoting taxonomy and looking after the collections that underpin this work
- Generating knowledge to understand trends within the context of global environmental change and that support decision-making relating to the protection and sustainable use of biological resources
- Determining biodiversity conservation needs and priorities
- Assisting in the development of a biodiversity framework, bioregional plans and strategies
- Disseminating information on biodiversity and maintaining relevant data bases

In addition, as a science –policy interface institution, SANBI provides science based policy advice to the Minister of Environmental Affairs. This is a very broad mandate and SANBI recognises that it needs to prioritise its work. The Institute has recently undergone an external review of its science programmes where it was identified that SANBI should develop a clear strategy relating to the type of directed research it needs to undertake. This has two components: i) which societally-determined problems should be prioritised, and (ii) what role

does SANBI play in the continuum from pure through applied research to implementation work. SANBI wishes to appoint a service provider who can assist SANBI with this process.

2. Scope of work of Service Provider

The scope of work of the Service Provider is as follows:

- 2.1 Work with SANBI management to map out a process for developing the science strategy

Deliverable 1: a document summarising the process with dates for workshops, information requirements and meetings with key staff.

- 2.2 Facilitate the identification and analysis of options
 - a. Facilitate workshops and interactions with staff and apply strategic planning and visioning tools to identify and interrogate options (e.g. using SWOT assessments).
 - b. Where appropriate analyse background documents
 - c. Guide SANBI staff in relation to background work and/ or analyses that may be required to inform the strategic planning process
 - d. Write up a report on the different options

Deliverable 2: a report outlining the different options and an analysis using appropriate tools or other appropriate frameworks

- 2.3. Facilitate the development of a strategy document which identifies key science products as well as the relevant research broken down into areas that should be outsourced and those that should be developed or strengthened in SANBI.

Deliverable 3: A draft strategy document laying out SANBI's key science products and the relevant research activities.

The Service Provider will be expected to liaise with SANBI science management and the science lead at the National Zoological Gardens.

3. Skills, competencies and other requirements

In order to fulfil this role, the Service Provider should have the following skills and competencies. The response to the terms of reference should indicate the extent to which the Service Provider fulfils these requirements.

Knowledge, experience and skills are required in:

- Strategic planning
- Science planning processes.
- Application of tools to identify and analyse strategic options
- Workshop facilitation
- Report writing

- Ability to work with management teams in an organisation
- Delivery of quality and accurate deliverables within tight agreed timeframes
- Understanding of the science policy interface

Knowledge and understanding of the following will be an advantage:

- The biodiversity sector in South Africa
- The biodiversity institutions in South Africa
- The science sector in South Africa
- National development priorities for South Africa
- South Africa's commitments in terms of multilateral environmental agreements
- Current research / science platforms in South Africa

4. Requirements for proposals and quotations

Service Providers interested in contributing towards this project should submit a concise written proposal that addresses the scope of work and the above requirements and outputs. The proposal must include:

4.1 A response to the Terms of Reference

- Description of how the Service Provider is qualified and able to meet the requirements of the project detailed above, including a brief section on methods applied and lessons learnt in similar processes.
- Description of the tools and processes that the consultant would use to assist with strategic planning specifically for science programmes.
- A proposed workplan for the Service Provider to accomplish the deliverables mentioned above in the timeframe stipulated in the budget section below.
- Details of the Service Provider (individual or team), including relevant skills, experience and track record – short CV(s) must be included.
- Contact details of at least three current or recent clients, preferably in related work.
- Examples of relevant recent strategic planning processes led by the Service Provider.

4.2 Budget

This is a specialist consultancy and, as such, quotes must state the daily rates of the Service Provider, with VAT listed separately if applicable. The contract will require approximately 20-25 days of a Service Provider's time between December 2017 and end June 2018, depending on date of commencement of contract. This includes availability for a two day workshop planned for 5-6 December 2017.

Notes for the budget:

- The budget should only cover the Service Provider's time.

- The rates of remuneration must not exceed rates prescribed by a professional body e.g SACNASP, PLATO but are negotiable
