The work comprises of repairing of a viewing deck and a pedestrian bridge rail, and painting of palisade fence, all as hereafter specified.

PAINT SPECIFICATION

1) Palisade fence (Entrance 2 to the Crocodile River bridge to the Boabab tree fence) painting

Preparation

Loosen and temporarily place aside the razor wire
Remove all loose materials of old paint.
Smoothen the panels before applying the first paint.
