To appoint a service provider to provide expert advice to SANBI and Statistics South Africa on the EU-funded Natural Capital Accounting and Valuation of Ecosystem Services project.

SANBI Ref:

1. Background

The Natural Capital Accounting and Valuation of Ecosystem Services project has been launched by the United Nations Statistics Division (UNSD), United Nations Environment (UNE), the Secretariat of the Convention on Biological Diversity and the European Union (EU). This EU-funded project aims at assisting the five participating partner countries, including South Africa, to advance the knowledge agenda on environmental and ecosystem accounting and initiate pilot testing of System of Environmental-Economic Accounting (SEEA) Experimental Ecosystem Accounting (EEA), with a view to improving the management of natural biotic resources, ecosystems and their services at the national level as well as mainstreaming biodiversity and ecosystems in national level policy-planning and implementation.

The EU-funded Natural Capital Accounting (NCA) project will be led in South Africa jointly by Statistics South Africa (Stats SA) and the South African National Biodiversity Institute (SANBI), with project co-leaders from Stats SA and SANBI respectively, and a project management unit based in SANBI. Implementation of the project will take place for a period of 24 month period over the calendar years 2017-2019. Deliverables of the project will include: pilot ecosystem accounts in South Africa in physical and monetary terms; a national strategy for advancing environmental-economic accounting; guidelines and methodology that contribute to the in-country implementation and global research agenda of the SEEA EEA; an indicator set based on SEEA EEA in South Africa in the context of the 2030 Sustainable Development Agenda, Aichi Targets or other international indicator initiatives; and a national forum and national training workshop to enhance capacity and enlarge the community of practitioners on SEEA EEA.

The project builds on previous work led by Stats SA and SANBI as part of the Advancing Natural Capital Accounting project (ANCA), in which South Africa was one of seven pilot countries. ANCA was led by the United Nations Statistics Division (UNSD) in partnership with United Nations Environment (UNE) and the Convention on Biodiversity (CBD), with funding from the Government of Norway.

2. Objectives of the work

SANBI wishes to appoint a service provider with the necessary skill set to provide expert advice and guidance to the project co-leaders and project team on the establishment and implementation of the EU-funded NCA project, particularly in relation to requirements for constructing policy-relevant physical ecosystem asset and ecosystem

service accounts and linking them to valuation and other demographic and economic data.

3. Requirements of the service provider

The successful service provider will be responsible for the following activities in line with the above objective:

- a) Providing technical input into the development of the programme of work for the project;
- b) Providing technical input into the national strategy for natural capital accounting to be developed by the project;

4. Deliverables
