The [Western Cape](#) currently faces a serious drought due to poor rainfall during the 2015, 2016 and 2017 winter seasons. The demand for water has also steadily increased every year due to the province's rapidly growing population and economy. This, as well as climate change, has added significant pressure on the province's water supply.

SANBI's CD: Conservation Gardens & Tourism was requested at the October 2017 Executive Committee meeting to establish a new internal SANBI committee to provide senior management oversight over SANBI's Western Cape National Botanical Gardens (NBGs) that are being impacted by severe drought.
