The South African National Biodiversity Institute (SANBI) wishes to appoint a service provider to offer a workshop for postgraduate students, scientists and horticulturists who are at entry level of their respective Career Ladders

1. Introduction and Background

Human Capital Development is a strategic focus for SANBI with the aim of attracting young people to biodiversity careers and to build relevant technical skills in biodiversity professionals and technicians.

SANBI supports postgraduate studies for both staff and students in biological and life sciences, particularly in critical skills areas. In order to ensure successful completion of these studies, it is important that students and staff are provided with the relevant support. This support could be in the form of development of research proposal, research design, improving scientific writing by acquiring sound writing practices, writing successful grant applications, etc.

Several scientists and horticulturists at SANBI, who are at the early stages of their careers, require similar support to equip them with the necessary skills to progress on the career ladder.

We invite service providers to submit quotations for a workshop for 15-20 participants. The workshop should take place at the Kirstenbosch Research Centre, Cape Town. We aim to offer the workshop every year over a 3 (three) year period.

Service providers who fail to score a minimum of 70 out of a possible 100 points for functionality will not be eligible for further consideration.

The second stage will evaluate the price and preferential points of those bids that meet the minimum threshold for functionality.
