1. Background

The South African National Biodiversity Institute (SANBI) and DST/NRF Centre of Excellence for Invasion Biology (CIB) at Stellenbosch University collaborated to produce the first National Status Report on Biological Invasions. SANBI is mandated by the National Environmental Management: Biodiversity Act (Act 10 of 2004) and its Regulations (Alien and Invasive Species Regulations, 2014) to monitor and report regularly to the Minister on the status of all listed invasive species. In order to fulfil this mandate, SANBI must submit a report on the status of listed invasive species to the Minister within three years after the regulations come into effect, and at least every three years thereafter. The first report was completed in March 2017. The subsequent report is due by October 2020.

The team drafting the report in consultation with its Reference and Advisory committee intends to appoint an independent review editor in the final stages of completion of the report. The purpose of the review editor is to ensure that the review process followed to produce the report was appropriate and adequate. In addition it is envisaged that the review editor will also provide recommendations to improve and strengthen the process and research that are required to produce subsequent reports.

2. Objective
