Service provider to conduct a strategic review of the mandate of the South African National Biodiversity Institute (SANBI)

Background

The South African National Biodiversity Institute (SANBI) leads and coordinates research, and monitors and reports on the state of biodiversity in South Africa. The institute provides knowledge and information, gives biodiversity planning and policy advice, pilots best-practice management models in partnership with stakeholders, and engages in ecosystem restoration and rehabilitation thus bridging the gap between science, knowledge, policy and implementation.

SANBI is a public entity under the Department of Environmental Affairs (DEA). It derives its mandate primarily from the National Environmental Management: Biodiversity Act (Act 10 of 2004), but also from a range of other national developmental priorities and international conventions. As part of a broader review of the mandates of public entities under the Department of Environmental Affairs, SANBI has been requested by the Minister of Environmental Affairs to strategically review its mandate, and its activities in line with DEA and the evolving priorities of Government as well as the environmental sector. A mandate review is envisioned as occurring every five years.

Objectives of the work

SANBI therefore wishes to appoint a service provider to conduct a strategic review of the institute's mandate according to the attached Mandate Review Framework. The intention of the mandate review is:

- To ensure that the SANBI mandate aligns with government priorities
- To ensure that SANBI activities align with its mandate
- If necessary, to recommend changes to the mandate, which may include consolidation of mandates within the sector, mandates where further action is required or mandates that are no longer active or relevant.

The mandate review is a strategic rather than a legislative process.

Requirements of the service provider

The service provider will be responsible for the following activities in line with the above objectives:

- a) Develop an approach and guiding plan for the mandate review and associated report in consultation with SANBI management.
- b) Conduct a broad review of relevant background information pertaining to the institute's mandate, including:
 - The mandate as stated within relevant legislation
 - Other policy-based sources of mandate
 - The strategic outcome-oriented goals of the institute
 - Other national development priorities
 - Relevant concurrent reviews, internal strategic reviews or reports
- c) Facilitate an internal and external consultation process, including:
 - Interaction at leadership, branch-level and executive committee meetings to understand SANBI management's current interpretation of, and response to, its mandate.
 - Conduct an internal mandate review workshop with SANBI staff to understand how the mandate and SANBI's programme of work is contributing to national development goals and government priorities.
 - Facilitate an external workshop with relevant stakeholders within the environmental and/or biodiversity sector to ascertain the position of the institute and its mandate within the broader development context.
- d) Compile and present a mandate review report:
 - Compile a draft report of the findings of the mandate review, formatted according to an agreed structure, including:
 - i. vision, mission and values
 - ii. legislative and other mandates
 - iii. situational analysis
 - iv. strategic outcome-oriented goals of the institute and links to national developmental goals and priorities

- v. links to other mandates
- vi. mandate recommendations.
- Integrate feedback into the report from relevant committees, the SANBI Board, the Department of Environmental Affairs, including giving presentations and conducting feedback sessions to these structures where necessary.
- Integrate all comments and finalise the report for sign-off by the SANBI CEO and Board Chairperson submission to the Minister of Environmental Affairs.

Deliverables

The service provider will be appointed over a 4-month period beginning in July 2018. The service provider will be required to submit the following:

Skills and competency required

In order to fulfil this role the service provider should have the following demonstrable skills and competencies:

- Excellent knowledge and experience in the following areas:
 - understanding of national legislation and policy
 - strong familiarity with national developmental priorities (such as the National Development Plan and Medium Term Strategic Framework)
 - knowledge of the environmental sector, and preferably the biodiversity sector, including its strategies
 - Experience with engaging with government institutions at various levels, including national, provincial and local government as well as NGO's and academic institutions

- Working with teams and managing processes that require detailed inputs from a range of stakeholders.
- Proven complex report writing experience and management of large document structure.
- Excellent conceptual and analytical skills
- Self-motivated and results driven, ability to work independently and deliver efficiently on high quality deliverables within tight timeframes
- Proven ability to deliver required products within an agreed fixed budget
- Other
 - Willingness to travel nationally for meetings as required

 - Postgraduate qualification in a relevant field

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE Status Level Certificate.
