The South African National Biodiversity Institute (SANBI) wishes to appoint a consultant to provide support to SANBI's Climate Change Division

1. BACKGROUND

The Small Grants Facility (SGF) is a four-year community-based adaptation pilot project which aims to ensure that vulnerable, rural communities in two project target areas in South Africa (Namakwa District in the Northern Cape and Mopani District in Limpopo) have reduced vulnerability and increased resilience to the anticipated impacts of climate variability and change.

The SGF project is piloting a small granting mechanism known as enhanced direct access (EDA), which allows civil society organisations to access climate finance to implement locally relevant adaptation projects at the community level in at least one of the three investment windows: Climate-Smart Agriculture, Climate-Resilient Livelihoods and Climate-Proof Settlements.

The SGF project is funded by the Adaptation Fund, implemented by the South African National Biodiversity Institute (SANBI) as the National Implementing Entity, and executed by SouthSouthNorth Trust as the Executing Entity. The project has three components:

- Component 1: Providing small grants to vulnerable communities that deliver tangible and sustainable benefits;
- Component 2: Empowering local institutions to identify and implement adaptation response measures; and
- Component 3: Compiling and sharing lessons learned to facilitate future scaling up and replication of small grant-financing approaches.

The SGF project was initiated in September 2015 and is thus past the mid-way point in implementation of the 4-year project period. A Mid-Term Evaluation of the project has been commissioned, and is currently underway. The project has a total budget of USD 2,442,682.

2. OBJECTIVES OF THE CONSULTANCY

SANBI's is looking for an individual consultant support SANBI's SGF project management and oversight processes. This will include coordination of governance, financial management and reporting processes and the provision of project management and technical support.

The programme of work will take place over an 18 month period. There is a possibility that this period could be extended, depending on the timing of the project and the approval of other related proposals.

The consultant will be based in SANBI's Kirstenbosch office. Use of an office, phone line and computer will be provided, and a disbursement budget will be provided to cover direct costs associated with workshops, travel and other approved project-related activities.

3. DUTIES AND RESPONSIBILITIES

The duties will be performed by a consultant with sufficient small grant project management experience. The duties will be performed over an 18 month period, beginning as soon as possible. The consultant will need to be based at SANBI's offices in Cape Town, and must be prepared to travel nationally.

The consultant will be required to:

- Provide technical support to the SGF project:
 - Support the Executing Entity to meet the objectives of the SGF project;
 - Support the strategic development and implementation of the knowledge management and learning component of the project;
 - Ensure that lessons emerging from the SGF project are appropriately captured to inform related processes; and
 - Undertake regular site visits and report on progress.
- Lead processes to monitor compliance of and report on the SGF project:

 - Design project performance tracking tools and templates;

- Support processes to capture SGF project learning and develop case studies.
- Support the Green Climate Fund pipeline development and operationalisation process:
 - Undertake research and perform benchmarking exercises against small grant facilities in South Africa; and
 - Lead the production of SGF-related deliverables of SANBI's Green Climate Fund Readiness and Project Preparation Facility contracts.
- Provide ad hoc support to SANBI's Climate Change Division as needed:
 - Represent the Climate Change Division and participate in meetings and workshops;
