The South African National Biodiversity Institute (SANBI) wishes to appoint a consultant to provide support to SANBI's Climate Change Division

1. INTRODUCTION

SANBI wishes to appoint an auditor to conduct an audit of the uMngeni Resilience Project (URP) at the uMgungundlovu District Municipality (uMDM) in KwaZulu-Natal. The uMDM is the Executing Entity responsible for implementing the URP, which is a five year project that aims to increase the resilience of vulnerable communities to the impacts of climate change. The project is piloted at four sites across three Local Municipalities in the District.

The project is funded by the Adaptation Fund, with SANBI as the National Implementing Entity. As the Executing Entity the uMDM receives funds from SANBI in quarterly intervals in line with the Funding Agreement between the two entities.

The project started in September 2015. The project financial year runs from 1 October to 30 September.

An audit of the project at the uMDM is required for the period 1 October 2016 to 30 September 2017 i.e. the second year of implementation of the URP. The Municipality's financial year runs from 1 July to 30 June, meaning the required audit cuts across two uMDM financial years.

2. BACKGROUND

The uMDM is a District Municipality. A Project Management Unit (PMU) has been established within the Community Services Department of the Municipality to manage the project. The URP uses uMDM processes and systems for transactions related to the Project. The audit is restricted to transactions related to the URP only at the uMDM for the period 1 October 2016 to 30 September 2017.

The scope of the audit is limited to uMDM's expenditures, which are defined as including all disbursements listed in the quarterly financial reports submitted by the uMDM to SANBI.

The audit should be performed in terms of International Standards on Auditing (ISA) with special reference to the Auditor's Report on Special Purpose Audit Engagements.

3. SCOPE OF WORK

The scope of audit work shall be in accordance with ISA and cover the overall management of the URP's implementation, monitoring and supervision. To this effect, the scope of the audit shall cover the following areas as they are performed at the level of the project:

Human resources:

- Identify specific deficiencies and areas of weakness in systems and internal controls of uMDM that have come to the auditors attention, especially with regard to procurement and payments, and make recommendations for improvement;
- Report on actions taken by management to address deficiencies and areas of weakness reported in the past; and
- Bring to SANBI's attention any other matters that the auditors believe are pertinent.

5. AUDIT REPORT

The audit report should clearly indicate the auditor's opinion and include at least the following:

- The amount of expenses audited;
- The Global Statement of Expenditure for the period from 1 October 2016 to 30 September 2017;
