CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.

SANBI has been allocated funds by the DEA for the period the period 2016/17 – 2018/19 for the refurbishment, upgrading, repair and maintenance of existing immovable infrastructure, vehicles and equipment as well as the construction of new infrastructure. The infrastructure will address the needs of SANBI from administrative, research and educational and tourism perspectives.

Projects have been identified for implementation over the MTEF at each of SANBI's existing campuses and sites across the country.

Established in 1982, Walter Sisulu National Botanical Garden covers an area of 300 hectares and conserves many indigenous plants. In addition to over 200 bird species, the area provides a home to a range of small mammals and reptiles. The garden amenities include, amongst others, a restaurant, kiosk, concert stage and several venues for hire by members of the public.
