- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.

BIODIVERSITY STEWARDSHIP NATIONAL GUIDELINE DOCUMENT

The South African National Biodiversity Institute (SANBI) wishes to appoint a service provider to design a print ready file of the revised National Biodiversity Stewardship Guideline Document

1. Background

The Biodiversity and Land Use Project, funded by the Global Environment Facility (GEF) and implemented by SANBI and its partners, seeks to mitigate multiple threats to biodiversity by increasing the capabilities of authorities and land owners to regulate land use and manage biodiversity in threatened ecosystems at the municipal scale. The project aims to deliver a package of measures that will ensure future land use practices and permitting decisions do not compromise biodiversity and ecosystem functioning.

One of these measures is biodiversity stewardship. Biodiversity stewardship is an approach, led by conservation authorities, to securing land in biodiversity priority areas through entering into agreements with private and communal landowners. Conservation NGOs often play a key supporting role. The objective of biodiversity stewardship is to conserve and manage biodiversity priority areas through voluntary agreements with landowners.

The National Biodiversity Stewardship Technical Working Group, chaired by SANBI, is in the process of revising the 2009 National Biodiversity Stewardship Guideline document. The national guideline document aims to guide the successful implementation of biodiversity stewardship from ground level up, starting at land owner engagement through to formal declaration and further to ongoing sustainable support.

The intended audience for the revised guideline document includes: biodiversity stewardship and protected area expansion extension staff, managers and planners in conservation agencies within national and provincial government as well as within conservation NGO's, municipal environmental assessment practitioners, and private sector property developers.

Currently, the guideline is in the copy editing process and will require a graphic design service to complete the product.

2. Objectives of consultancy

Through the Biodiversity and Land Use Project, SANBI wishes to appoint a graphic designer for the layout and design of the guideline document in order to produce two deliverables:

- 1) A final print ready file to be handed over to printers and;
- 2) A PDF version optimising file size and image quality for electronic distribution.

To achieve the above two deliverables the role of the graphic design service provider is twofold: 1) to produce a design and layout template for approval by the guideline document sub-committee of the National Biodiversity Stewardship Technical Working Group and 2) to populate the agreed upon template with the final content from the copy editing process. Images will be provided by the guideline document sub-committee.

It is the role of the designer to ensure that the guideline design and layout is suitable to best meet the intended use and audience of the guideline document.

3. Main requirements

To produce and present a Biodiversity Stewardship Guideline document that has been designed in accordance with the National Biodiversity Stewardship Technical Working Group.

The final print ready file is to be delivered in an electronic file format agreed upon at project inception. Prospective service providers must indicate in their application in which design software they are familiar with and which file formats they are able to supply the final electronic print ready file in.

The version for electronic distribution must be in PDF format. The maximum file size for the PDF file will be agreed upon after the design and layout template has been finalised.

4. Deliverables and timeframes

The successful service provider will be required to fulfil the following activities in line with the stated objectives:

Project Management Functions:

- To meet with representatives of the guideline document sub-committee to agree on the design themes and layout options;
- To liaise closely with a representative from the guideline document sub-committee with regards to any queries or challenges that emerge through the design and layout process as well as to provide regular updates regarding progress towards milestones;
- To liaise effectively with the copy editor should any challenges arise in the layout and design process that require input from the copy editor;

- To accurately and securely file electronic copies of each version worked on.

Graphic Design Functions:

- To produce and present a layout and design template that meets the branding requirements and the layout and design guidelines of the National Biodiversity Stewardship Technical Working Group and SANBI;
- The layout and design template must be in the agreed design software and must be approved by the Guideline Document sub-committee before work commences on populating the template with content;
- The design template must include design and layout stipulations for each of the distinct components of the guideline document including, but not limited to:
 - cover page
 - document reference page
 - authorisation page
 - glossary
 - table of contents
 - basic page layout
 - heading structures
 - accent boxes
 - the highlighting of key terminology
 - images
 - tables
 - headers and footers
 - page numbering
 - references
 - appendices
- To optimize images for print at the correct size and resolution;
- To populate the design template with the copy edited content (approximately 115 pages) and supplied images. The final draft version is to be provided in an agreed upon, compatible format for use by the appointed printers.

The design and layout function must start as soon as possible after acceptance of quote, or as close to this date as possible, for a period of three months starting in July 2018.

Deliverables will be presented in the form of a final designed guideline document in an agreed upon compatible format for the printers.

5. Skills and competencies required

The service provider needs to have the necessary background, understanding and working experience to be appointed.

Excellent knowledge, experience demonstrable skills and competencies are required in the following areas:

- Graphic design and layout development of large documents
- The accurate and detailed management of complex specialised information.
- Attention to detail and consistent application of a design template.
- Management of large document structure.
- Excellent conceptual and analytical skills.
- Self-motivated and results driven, ability to work independently and deliver efficiently on high quality deliverables within tight timeframes.
- Ability to deliver required products within an agreed fixed budget.

Other:

- Tertiary qualification in graphic design.
- Broad understanding of environmental, biodiversity and conservation concepts.

6. Requirements for proposals and evaluation criteria

The response to the terms of reference should indicate the extent to which the service provider fulfills these requirements. In addition, proposals should include a recent CV as well as examples of recent writing to demonstrate skills and experience.

6.1 Service providers interested in this project should submit a concise proposal giving the cost of the work and providing examples of relevant previous work.

6.2 The proposal must include:

- Details of the consultant or project team, including relevant skills, experience and track record.
- A brief description of the approach and methodology to addressing the objectives and specific requirements.
- Work plan, including proposed start and completion date and timeframes for activities and deliverables against which payments will be made.
- A list of the layout and design software programs that the consultant is competent and licensed to use to produce the required deliverables.
- Details of any contribution to empowerment of historically disadvantaged individuals (HDI) and/or transformation of the sector.
- Equity status of service provider (HDI, women and disability) according to the attached form (SBD 6.1).
- A detailed and complete budget for the proposed work, including disbursements and VAT.
- Examples of relevant previous work that the service provider was personally responsible for, which demonstrates project planning, project development and writing ability to demonstrate skills and experience as highlighted above.

- A detailed and complete budget for the proposed work, including fees (rate per day), disbursements and VAT. Each of these should be provided separately. Travel and accommodation disbursements should NOT be included in the budget. Travel requirements will be discussed upon appointment of selected service provider at the inception meeting.

6.3 The Preferential Procurement Policy Framework Act (No. 5 of 2000) and SANBI's procurement process applies to these Terms of Reference. Note that service providers are required to comply with the processes outlined here and failure will result in the disqualification of proposals:

- Service providers are required to submit a valid tax clearance certificate with their proposals (see SBD 2 form). Where the service provider is not in possession of a valid tax clearance certificate, this should be applied for in good time ahead of the proposal deadline.
- The 80/20 point system will be applied in evaluating proposals, where price constitute 80 points and the BBBEE scorecard constitutes 20 points.

6.4 Functionality evaluation criteria:

** Service providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2011 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of

2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE status level certificate.

7. Reporting requirements and management
