CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

The South African National Biodiversity Institute (SANBI) wishes to appoint a pool of technical experts to provide support to SANBI's Climate Change Division.

1. Introduction

The South African National Biodiversity Institute (SANBI) wishes to appoint suitably qualified and experienced service providers to join a pool of technical experts that will support SANBI's programme of work as an Accredited Entity (AE) of the Green Climate Fund (GCF).

2. Background

As an AE of the GCF, SANBI is responsible for presenting applications for funding to the GCF, and then overseeing, supervising, managing and monitoring approved projects and programmes.

SANBI initiated its GCF project pipeline development process with a call for Expressions of Interest (EoIs) from parties wishing to make use of SANBI's services as an accredited GCF entity. Over 120 EoIs were received. These EoIs will now be screened and reviewed, and those that best meet SANBI's criteria will be developed into a set of Concept Notes and Funding Proposals for submission to the GCF.

In support of this process, SANBI wishes to establish a pool of technical experts. It is anticipated that these experts will support SANBI's processes to review and screen EoIs, and to develop and review technical components of Concept Notes and Funding Proposals, in anticipation of their submission to the GCF.

3. Objectives of the pool of technical experts

The pool of technical experts will support SANBI's GCF project development process, towards ensuring that project proposals are technically sound, respond to adaptation needs, deliver tangible adaptation benefits and are compliant with relevant environmental and social safeguards.

In particular, the technical experts will:

- Review and assess Eols or elements of Eols, Concept Notes and Funding Proposals.
- Provide recommendations for technical improvements to Eols, Concept Notes and Funding Proposals.
- Identify technical gaps and propose mechanisms for addressing these gaps.
- Provide recommendations on mitigation measures that are required to manage environmental, social and policy risks identified in the proposed projects.
- Prepare technical inputs for Concept Notes and Funding Proposals.
- Support SANBI to respond to GCF comments.
- Participate in technical meetings and workshops.

5. Deliverables, time frames, level of effort and remuneration

Service providers who are appointed to the pool of technical experts will be requested to provide inputs from their own locations. Technical experts will be provided with the specific terms of reference and relevant background material for each assignment. The level of effort required will be determined on a case by case basis. Upon receipt of the specific terms of reference, the technical experts will be asked to indicate their availability to provide the requested inputs within the set time frame. Deliverables will be in the form of reports, as per the specific assignments that are set.

Where more than one technical expert is identified for a competency area, the opportunity will be rotated. Remuneration will be based on 70% of the rate of the applicable Department of Public Service and Administration (DPSA) salary band, as set out in the most recent DPSA guide on hourly fee rates for consultants. The applicable rate will be for short or long term services (as applicable), without mark up and with partial overheads.

The period of service will start from August 2018 and continue intermittently on a rolling three year basis. Service providers will only be engaged in accordance with their area of expertise, and only if needed.

6. Requirements for applications and evaluation criteria

Service providers interested in this opportunity should submit a concise application that includes:

- A cover letter outlining relevant knowledge, experience and skills in the technical area(s) of expertise that apply. Technical experts are encouraged to be as specific as possible. Please note that experts will need to have a minimum of 10 years' experience in their field of expertise.
- An updated Curriculum Vitae (CV) clearly delineating qualifications and experience with regard to the selected technical area(s) of expertise. If more than one area of expertise is selected, the qualifications and experience as they relate to each area of expertise should be clearly demarcated.
- Three examples (such as assignments or assessments similar to the scope of work that is envisaged here) that illustrate competencies in relevant areas of expertise.
- A motivation for the DPSA consultant salary band that will apply.
- BBB-EE level of contributor certificate according to the attached form (SBD 6.1).
- Contact details of at least three current or recent clients who are familiar with the technical area of expertise that is the subject of the application.

The application should give clear examples of the service provider's proficiency and recent project

experience in terms of the above skills, abilities and competencies.

The Preferential Procurement Policy Framework Act (No. 5 of 2000) and SANBI's procurement process applies to these Terms of Reference. Note that service providers are required to comply with the processes outlined here and failure will result in the disqualification of proposals:

- Service providers will be required to submit a valid tax clearance certificate with their application (see SBD 2 form) or a Central Supplier Database (CSD) report. Where the service provider is not in possession of a valid tax clearance certificate, this should be applied for in good time ahead of the proposal deadline.
- The 80/20 point system will be applied in evaluating proposals, where price constitute 80 points the BBBEE scorecard constitutes 20 points.
- Qualified technical experts will be requested to register on the CSD of the National Treasury, either as individuals or as part of organisations to which they are affiliated.

7. Functionality evaluation criteria:

Please note that remuneration will be based on 70% of the DPSA's latest schedule on hourly fee rates for consultants, at the applicable rate and, as such, this bid will only be evaluated on functionality and equity.
