CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

TERMS OF REFERENCE FOR APPOINTING MOBILE APPLICATION DEVELOPER/SERVICE PROVIDER

The South African National Biodiversity Institute (SANBI) wishes to appoint a service provider to develop the organisation's mobile APP and give technical support for the period of two (2) years.

1. Background

Currently SANBI visitors have access to gardens information via the SANBI website. The information on the SANBI website represents the entire SANBI organisational information and does not provide access to specific and tailored gardens information required by SANBI visitors. This affects the SANBI visitor experience and negatively impact the SANBI brand.

2. Purpose

To address the challenge of providing specific gardens related information in an efficient manner there is a need to develop and implement a mobile based APP to enable SANBI visitors to access gardens information that will enhance the SANBI visitor experience.

3. Main requirements and deliverables

- This service provider should develop, maintain and support the mobile app to ensure that SANBI clients are able to access garden information with ease using the mobile APP.
- The service provider should provide technological intelligence that will enable SANBI to package and disseminate content suitable for its stakeholders.
- The service provider must provide guidance on the mobile app design
- The service provider is expected to develop the mobile application based on an approved design.

The appointed service provider should be able to provide a development, maintenance and support service which include the below listed requirements over a period of two (2) years subject to review for an agreed extension.

3.1 Functionality and features

- Geolocation
- User-generated content
- Linking – linking to the SANBI website for updated content
- Incorporated feedback from user-base.

- Create blogging function for horticulturists to share information
- Design - Service provider must provide design proposals (e.g. provide 3 designs for review and approval).

3.2 Technical requirements

- APP technical development, testing and implementation
- Must be developed for Android/IOS/Windows platforms (use of cross platform development language e.g. React Native)
- Cloud Architecture
- APP account set-up and hosting
- APP availability and performance

3.3 Service provider maintenance and support requirements

- Technical support and management of the APP database
- Technical support and management of the APP front-end (user interface)
- Technical support and management of the APP functionality (business layer)
- Technical support and management of all web services (integration /communication services)
- Data Storage, management and administration support
- Web services maintenance and update management.

3.4 Additional requirements

- APP performance metrics and reporting as defined by SANBI

4. Timeframes

The app development and deployment must commence from 01 November 2018 and completed by 31 January 2019. After successful deployment of the APP an agreed maintenance and support agreement for a period of two (2) years will commence.

5. Qualifications, experience and competencies

- The service provider needs to provide certified qualifications of development team
- The service provider needs to have a minimum of five (5) year experience in mobile APP development and deployment in an organization of a similar size or larger.
- They also require the necessary skills to train SANBI staff on utilising the software to publish the relevant content and user technical training.

6. Requirements for proposals and evaluation criteria

6.1 Service providers interested in this project should submit a concise proposal giving a breakdown of the scope, cost and time of the work and providing examples of relevant previous work.

6.2 The proposal must include:

- Details of the consultant or project team, including relevant skills, experience and track record.
- Work plan, including proposed start and completion date and timeframes for activities.
- Details of any contribution to empowerment of historically disadvantaged individuals (HDI) and/or transformation of the sector.
- Equity status of service provider (HDI, women and disability) according to the attached form (SBD 6.1).
- A detailed and complete budget for the proposed work, including disbursements and VAT.
- Examples of relevant previous work, which demonstrates project planning, development and writing ability.

6.3 The Preferential Procurement Policy Framework Act (No. 5 of 2000) and SANBI's procurement process applies to these Terms of Reference. Note that service providers are required to comply with the processes outlined here and failure will result in the disqualification of proposals:

- The 80/20 point system will be applied in evaluating proposals, where price constitute 80 points the BBBEE scorecard constitutes 20 points.

6.4 Functionality evaluation criteria:

In accordance with the National Treasury Instruction Note on the Amended Guidelines in Respect of Bids that include Functionality as a Criterion for Evaluation (issued 3 September 2010), this bid will be evaluated in two stages:

**** Service providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.**

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE status level certificate.

7. Reporting requirements and management

- Accountability will be to SANBI Marketing and Communication directorate.
- The service providers will however work closely with IT, Website and Social Media staff as part of SANBI Marketing and Communication directorate.

8. Contractual arrangements

- The contract will be drawn up between SANBI and the service provider.

- Invoices must indicate milestones achieved and deliverables produced.
