**The South African National Biodiversity Institute (SANBI) wishes to appoint a

the Eastern Cape**

1. BACKGROUND AND DISCUSSION

The Natural Science Collections Facility (NSCF) is one of the Research Infrastructure projects selected by the Department of Science & Technology (DST) for implementation from 2016/17 onwards. The NSCF comprises a network of institutions (universities, museums, science councils) that hold natural science collections, with a Co-ordinating Hub based at SANBI. A common strategic and business plan, with shared objectives and targets has been developed.

One of the objectives of the NSCF is the establishment of an online virtual museum that illustrates selected collection specimens for use by researchers and students globally. The NSCF is seeking a service provider to contribute to this project by photographing specimens at the Albany Museum in Grahamstown and the Port Elizabeth Museum.

2. SERVICES REQUIRED

SANBI requires the services of an experienced photographer to carry out imaging of the following specimens:

Albany Museum:

- 60 Karoo vertebrate fossils, one to multiple images depending on state of fossil fragmentation/preparation, if exists cranium images stacked (6 views) (360 images)

Port Elizabeth Museum:

- 42 frogs, 3 images per specimen of which 1 stacked (126 images)
- 100 reptiles, 7 images per specimen of which 4 stacked (700 images)

Total: 202 specimens, 1186 images

Note: Specimens range in size from approximately 2cm to 100cm in length.

Examples of images similar to those required are provided in Appendix 1.

The following deliverables and anticipated time required must be used as a basis for costing:

Note that external hard drives will be provided by SANBI for storage of images. The service provider will be expected to own or have access to all photographic and lighting equipment, hardware and software required for the project and this may not be included in the costing.

Limited budget is available for travel costs, depending on where the selected service provider is based but this will be negotiated separately and must not be costed in the submission.

3. SKILLS AND COMPETENCY REQUIRED

In order to fulfil this contract the service provider should have the following:

- Experience in photographing three dimensional still life objects, preferably preserved natural science specimens or other heritage objects
- Experience in the use of Z-stacking / focus stacking techniques
- Their own photographic and lighting equipment, stands / tripod, stacking software and necessary hardware

- The successful service provider will be required to be registered on the Central Suppliers Database (CSD) before the award of the contract
- The service provider must be willing to work on site at the Port Elizabeth Museum and at the Albany Museum (Grahamstown).
- The anticipated duration of the contract is two months, but the time required is 21 working days, which can be spread over the two month period.
- The service provider must be willing to work with staff at the institutions and to follow institutional processes and rules relating to the handling of irreplaceable specimens and to Health and Safety.

4. REQUIREMENTS FOR PROPOSALS

Service providers interested in contributing to this project should submit the following documents.

- 4.1.4 At least five examples of images taken
- 4.1.5 Details of photographic and lighting equipment, stands, software and hardware available for the proposed work.

4.2 Budget

- 4.2.1 A budget for the proposed work detailing daily rate and total for 21 days (see table in point 2)
- 4.2.2 Notes for the budget:
 - **The budget should only cover the prospective service provider's time.**

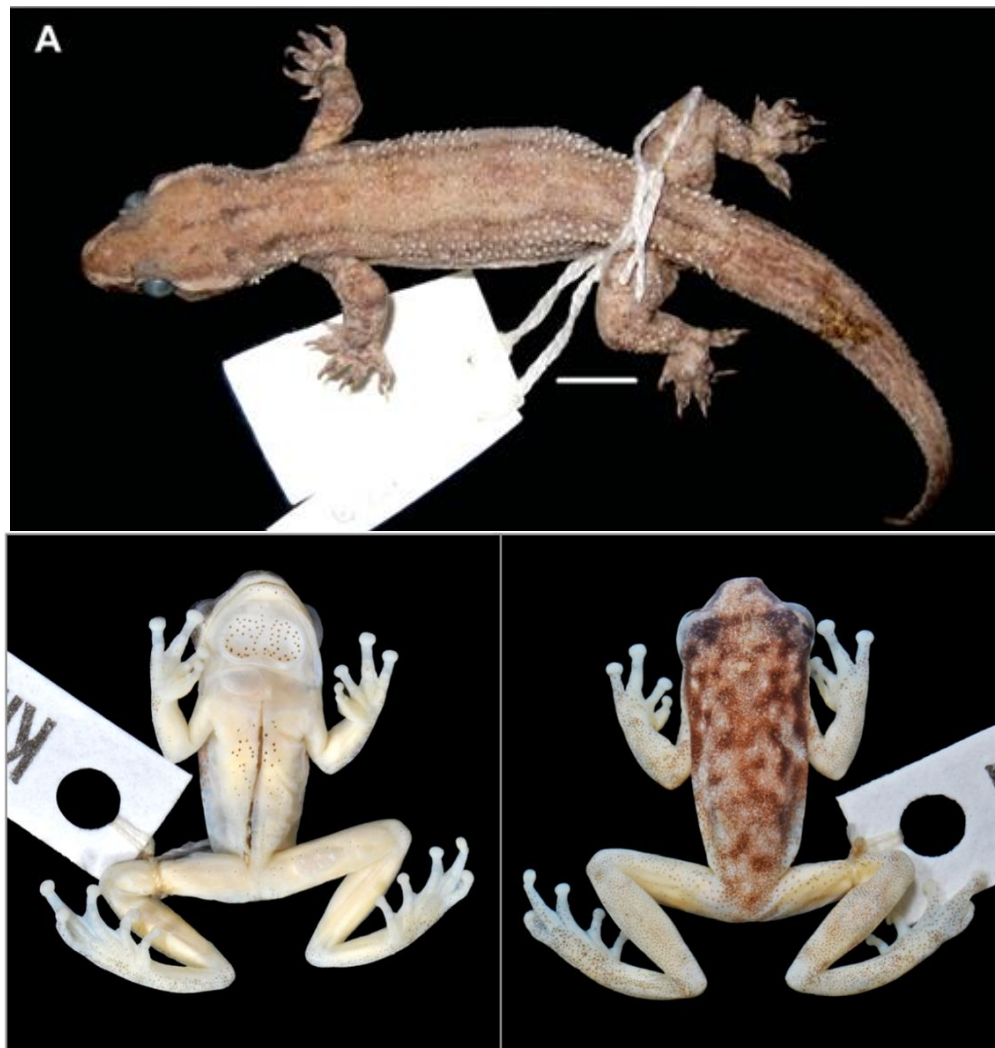
