The South African National Biodiversity Institute (SANBI) wishes to appoint a Service Provider to photograph selected preserved animal specimens in the Iziko Museum as part of the Natural Science Collections Facility (NSCF) work

1. BACKGROUND AND DISCUSSION

The Natural Science Collections Facility (NSCF) is one of the Research Infrastructure projects selected by the Department of Science & Technology (DST) for implementation from 2016/17 onwards. The NSCF comprises a network of institutions (universities, museums, science councils) that hold natural science collections, with a Co-ordinating Hub based at SANBI. A common strategic and business plan, with shared objectives and targets has been developed.

One of the objectives of the NSCF is the establishment of an online virtual museum that illustrates selected collection specimens for use by researchers and students globally. The NSCF is seeking a service provider to contribute to this project by photographing specimens at the Iziko Museum in Cape Town.

2. SERVICES REQUIRED

SANBI requires the services of an experienced photographer to carry out imaging of the following specimens at the Iziko Museum:

- 430 fish specimens, 4 images per specimen, all images stacked = 1720 images
- 20 frog specimens, 3 images per specimen of which 1 stacked = 60 images
- 50 reptile specimens, 7 images for each specimen, 4 of which stacked = 350 images

Total: 500 specimens, 2130 images

Note: Specimens range in size from approximately 2cm to >100cm in length.

Examples of images similar to those required are provided in Appendix 1.

The details of the requirements for the images (resolution, background colour, scale bar, colour chart) will be provided at the inception meeting and will need to be standardised.

A Hasselblad H5D system has been set up at Iziko Museum and should be used by the service provider for this project.

The following deliverables and anticipated time required must be used as a basis for costing of this work:

Note that external hard drives will be provided by SANBI for storage of images. Travel costs may be negotiated separately and will depend on location of the service provider's base relative to Iziko Museum, which is at 25 Victoria Street, Cape Town.

3. SKILLS AND COMPETENCY REQUIRED

In order to fulfil this contract the service provider should have the following:

- Experience in photographing three dimensional still life objects, preferably preserved natural science specimens or heritage objects
- Experience in the use of Z-stacking / focus stacking techniques
- Experience in the use of a Hasselblad system
- Own stacking software and appropriate hardware
- Home base in Cape Town or surrounds.

- The successful service provider will be required to be registered on the Central Suppliers Database (CSD) before the award of the contract
- The service provider must be willing to work on site at the Iziko Museum in Cape Town.
- The anticipated duration of the contract is three months, but the time required is 33 working days (excluding one day for the inception meeting), which can be spread over the three month period.
- The service provider must be willing to work with staff at the institution and to follow institutional processes and rules relating to the handling of irreplaceable specimens and to Health and Safety.

- 4.1.5 Details of experience in using photographic and lighting equipment, stands, software and hardware available for the proposed work including experience in the use of a Hasselblad system.

4.2 Budget

- 4.2.1 A budget for the proposed work detailing daily rate and total for 34 days (see table in point 2)

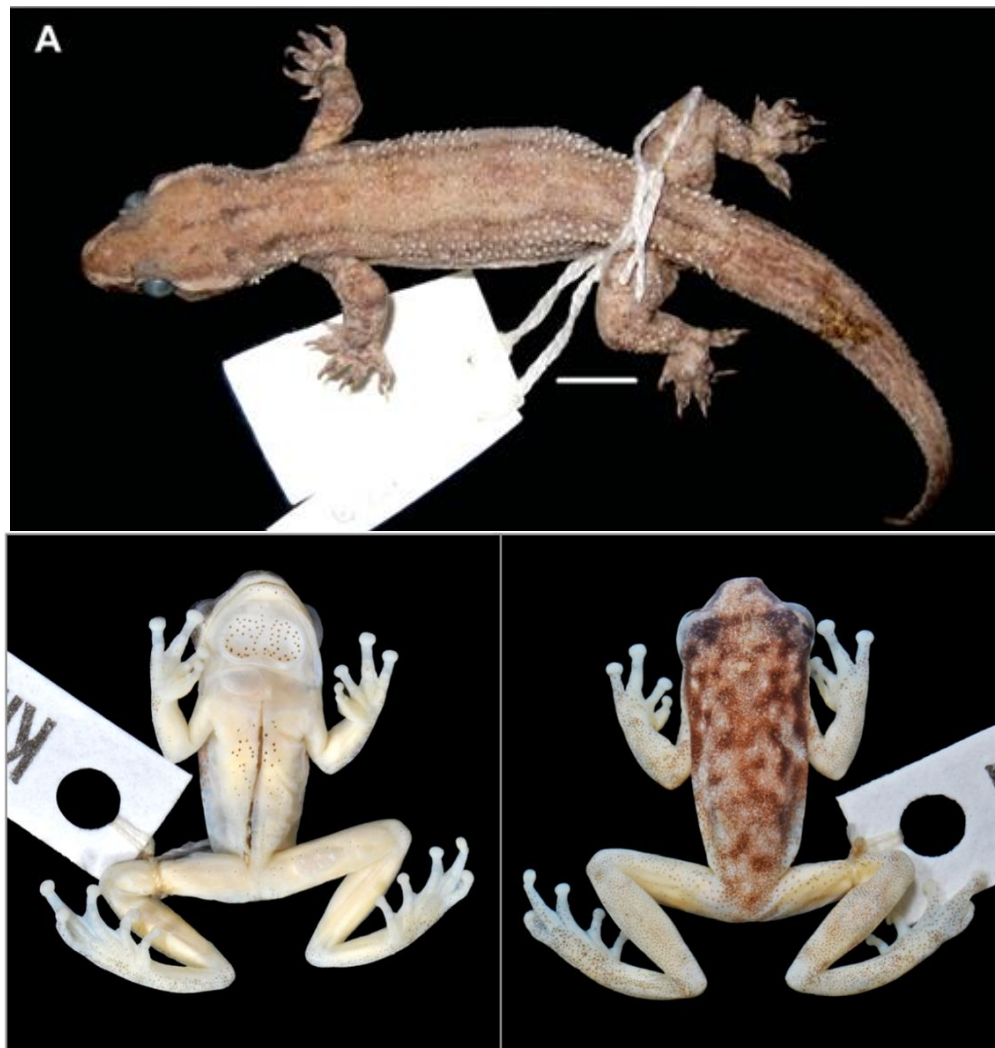
