CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.

Maintenance, Repairs and refuelling of Generators

1. SPECIFICATIONS

SANBI requires a company to maintain, repairs and refuel generators at the Pretoria National Botanical Garden (PNBG) for a period of six (6) months.

2. SERVICES REQUIRED

2.1 The service provider is required to:

Maintain, repair and refuel of generators at the Pretoria National Botanical Garden (PNBG) at the Pretoria National Botanical Garden (PNBG).

Generators:

- Herbarium: 1MVA Generator
- Restaurant (African Pride): 150kVA
- Tea Garden (Milkplum Café): 50kVA
- Concert Stage: 50kVA
- Education Centre: 50kVA
- Garden Offices: 50kVA

2.2 Standby Power Systems

Weekly Maintenance – simulate a power failure to ensure generators are fully operational. Test run shall be undertaken, if possible on load, and running hours, diesel levels, volt, ampere and frequency readings recorded.

Monthly Maintenance - of various generators should be done monthly. Maintenance implies and shall include monthly routine preventative maintenance, corrective maintenance, as well as breakdown maintenance.

Repairs – on various generators should be done as or when they occur. Costing will also be done as and when repairs to the generators are required. The service provider will procure required parts to repair generators and invoice thereafter.

Bids that fail to score a minimum of 60 out of a possible 100 points for functionality will not be eligible for further consideration.

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2011 pertaining to Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and 20 points will be awarded as per Points allocated to a bidder on the B-BBEE status level certificate
