CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

NATURE OF WORK

The SANBI Compton Herbarium houses irreplaceable collections of preserved plant specimens. These are susceptible to insect infestation (mainly *Lasioderma serracome* and crawling insects) and therefore the areas housing the collections and surrounding offices need to be fumigated and monitored at regular intervals. This document presents the scope of works for the fumigation and monitoring services required. The successful service provider will be expected to render the service as guided by the scope of work.

SCOPE OF WORK

1. Fumigation procedure **required**:
 - 1.1. Main treatment:
 - Fumigation (aerosol fumigation) of the respective areas with sufficient quantities of fumigant to reach all specimens.
 - Perimeter surface residual spray around cupboards and tables.
 - after-treatment ventilation process to allow for proper dispersal of the fumigant and the safe return of staff to the treated areas.
2. Fumigation chemicals/products **required**:
 - Fumigant suitable for dried plant specimens: - **M3 Tempo Aerosol Fogger**
 - Perimeter service residual sprays containing pyrethroid and chitin inhibitor: **Temp EW.**
 - Fumigation Contractor will ensure that all the areas are properly sealed and that the correct method of fumigation is carried out.

3. Date of anticipated fumigation service:

Treatment should commence on the afternoon of **Friday 14 December**, continuing through the weekend (treatment and ventilation). The fumigation contractor needs to hand back the building by the morning of **Tuesday, 18th December**. A certificate that the premises are safe to enter must be provided to the client.

4. Areas to be fumigated

All three levels of the Compton Herbarium and adjoining offices as well as the following offices within the rest of the Kirstenbosch Research Centre building:

B level: CREW office, B28, B31 downstairs passage in south wing B32a,

C level: C3, C7, C16, C18, C19, C20, C30, C31, C32, C33, C34, C36, C41, C41a, C41b, C52, Conservation Biology lab

5. Monitoring:

To determine the effectiveness of the method and chemicals used, a monitoring and response process involving the following is **required**:

- a) Placement and monitoring of pheromone insect traps at each site – number and placement should be calculated as per area.
- b) The effectiveness of the method and chemical should be monitored by the service provider (and in parallel by SANBI staff) at bi-monthly intervals up to 6 months after completion of the initial treatment. This information will inform further need for follow-up treatments (regularity and scale).
- c) Any infestation found during the 6 months following the date of fumigation should be dealt with as soon as practical through a follow-up fumigation (scope depending on the scale of the infestation found) to eradicate and avoid the spread of the infestation.

General requirements:

Fumigation Contractor will ensure that all the areas are properly sealed and that the correct method of fumigation is carried out.

The Fumigation Contractor must in writing, with this submission, explain in full detail form the procedure and equipment which will be used at this fumigation, to be used in each area, of the work to be carried out, before, during and after the treatment, up until the handing over of the premises as safe to enter for the client.

The fumigator shall be responsible to ensure no items which may not be treated are exposed to any pesticide.

Keys and a **scanner** will be handed over to the Fumigation Contractor, for the main entrance and the Herbarium, but the Contracted Security firm and **SANBI Security** to be responsible for the security of the building during the fumigation.

Fumigation Contractor must co-ordinate with **Anthony Magee**.

On completion, all cupboards must be put back into position and will be closed, and any mess must be removed from site by fumigation contractor.

GUIDELINES FOR SUBMISSIONS

Proposals should include information set out under the following headings (points 1 to 6):

1. **Company profile**. A detailed traceable (with contact details) **track record** showing experience in doing fumigation in museum, antiquarian or natural history collections. A list of the **team members** (and certification where relevant) involved in the fumigation process.
2. All relevant **certification required** for the fumigation process must be presented.
 - Registration as an accredited pest control operator (**Department of Agriculture**)
 - Registration with South African Pest Control Association (**SAPCA**)
 - Registration with Department of Labour (COIDA – Compensation for Occupational Injuries and Diseases Act)
 - Public liability insurance
 - Staff certification
3. A copy of the service providers **Health & Safety policy** should be submitted.
4. Full description of the **methodology** used in the fumigation process – explain in full detail the procedure and equipment that will be used before, during and after treatment (respective to each area).
 - Provide associated Material Safety Datasheet for each chemical used.
 - **Impact of chemicals**. Clear guidelines to the use and known side effects of the chemical used should be presented. This should specify the foreseeable impact of the chemicals on the staff, plant specimens and equipment in the affected areas.
 - **Quantities of chemical used** as per areas covered – the calculated amount of fumigation and residual surface spray products that will be used for each area to be treated.
5. Acceptance of the condition that a **safety certificate** must be presented by the service provider **after completion of the fumigation and ventilation** indicating that the area(s) fumigated is/are safe to occupy.

6. Provide a 6 month **warranty** for the areas fumigated.
