CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

The South African National Biodiversity Institute (SANBI) requires the services of a CCTV camera investigation for the existing bulk sewer infrastructure at the Pretoria National Botanical Garden.

1. Background and discussion

SANBI has been allocated funds by the DEA for the period 2016/17 – 2018/19 for a CCTV Camera Investigation of the existing bulk sewer infrastructure at the Pretoria National Botanical Garden.

The Pretoria National Botanical Garden, located in the suburb of Brummeria in east Tshwane, was established in 1946 after the University of Pretoria's experimental farm and private properties were acquired by the Department of Agriculture. The garden was formerly a research facility under the management of the Botanical Research Institute, which dates back to 1903. The Pretoria National Botanical Garden opened to the public in 1984.

The aim of this Terms of Reference is to ensure that all Entities intending to quote, submit proposals based on the same understanding of the project.

2. Invitation to Quote

Quotations are hereby invited for the services of CCTV Camera Investigations for the existing bulk sewer line at the Pretoria National Botanical Garden. Please see attached existing 'As-Built' of the existing sewer line.

2.1. Site Meeting and Briefing session

A compulsory briefing session for the services is to be held at the offices of the Pretoria National Botanical Garden at Environmental Education Centre at **10:00** on the **20 February 2019**

2.2. Scope of CCTV Investigation Service

The CCTV camera investigator shall be required to undertake all tasks of the project as agreed with SANBI.

The required tasks/ investigation shall include, but not limited to, the following:

- A CCTV pipe condition assessment survey of the existing sewer line from the National Herbarium building to the main sewage outlet, including:

- a. Locating manholes.
 - b. Distance between each manhole.
 - c. Slope of pipe.
 - d. Pipe dimensions.
- b.
 - a. Direction of flow.
 - b. Material of pipe.
 - c. Service conditions of pipeline.
 - d. High pressure cleaning of pipe lines (if required).

3. PROJECT ADMINISTRATION

A close relationship between SANBI, their Programme Manager, the appointed Civil Engineer and the CCTV Camera investigation Team must be maintained during the execution of the project. One representative/project leader should liaise with SANBI (i.e. a single point of contact).

The leader shall ensure that the work undertaken complies with the scope of work described in this Terms of Reference. Should it become necessary to undertake additional work not described in this Terms of Reference, the work should not be undertaken until full motivation has been submitted to SANBI and approval for the work and the associated expenditure has been granted.

The project leader shall ensure that project staff regularly report back on progress made and on any findings. The project leader shall convey the information without any delay to the SANBI Project Manager or the appointed Programme Manager. If deemed necessary, a project management meeting will be arranged to discuss a way forward. SANBI reserves the right to cancel the contract if the above procedure is not adhered to.

3.1. DELIVERABLES

The CCTV Camera investigation report with recommendations shall be prepared according to acceptable standards as specified by SANBI's Programme Manager.

One (1) hard copy and one (1) electronic (MS Word) copy of Draft and Final Reports will be presented to SANBI for review.

The following deliverables will be required:

- CCTV investigation report containing:
 - Collecting of field data and data storage.
 - Shape-file creation and a graphical representation of data on GIS software.

4. CONTENT OF PROJECT PROPOSALS

Invited CCTV camera investigation companies are required to submit, at their own cost, a separate Project Proposal, in which they demonstrate their understanding of the work to be undertaken and show their ability to perform the study described in this brief.

Proposals should be concise and cost effective from a compilation and evaluation point of view. The following information, amongst others, needs to be included in the Proposal:

- a) A detailed description of the proposed methodology and deliverables.
- b) Audit team, if more than one individual: capability and availability.
- c) Project programme detailing all aspects of work to be undertaken and associated milestones and deliverables.
- d) Cost details for each of the deliverables, including specialist studies and anticipated disbursements.
- e) Details, qualifications and relevant experience of all team members, including the lead consultant.
- f) List of similar projects previously carried out with contact details of the client representative(s).

5. EVALUATION OF PROPOSALS

In accordance with the National Treasury Instruction Note on the Amended Guidelines in Respect of Bids that include Functionality as a Criterion for Evaluation (Issued 3 September 2010), this bid will be evaluated in two stages:

Service providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.

- 5.2. The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy

Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE Status Level Certificate.

Failure to submit the B-BBEE certificate/sworn affidavit mentioned above will not necessarily result in a bid being disqualified, but no points will be awarded for B-BBEE status.

Sufficient information must be provided to allow the Evaluation Panel to score bids against all these criteria.
