CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

THE SOUTH AFRICAN NATIONAL BIODIVERSITY INSTITUTE (SANBI) REQUIRES THE SERVICES OF A PROFESSIONAL QUANTITY SURVEYOR FOR VARIOUS INFRASTRUCTURE UPGRADES FOR THE PRETORIA NATIONAL BOTANICAL GARDEN.

1. Background and discussion

SANBI has been allocated funds by the DEA for the period 2016/17 – 2018/19 for the refurbishment, upgrading, repair and maintenance of existing infrastructure as well as the construction of new infrastructure. The infrastructure will address the needs of SANBI from administrative, research and educational and tourism perspectives.

Projects have been identified for implementation over the MTEF at each of SANBI's existing campuses and sites across the country.

The Pretoria National Botanical Garden, located in the suburb of Brummeria in east Tshwane, was established in 1946 after the University of Pretoria's experimental farm and private properties were acquired by the Department of Agriculture. The garden was formerly a research facility under the management of the Botanical Research Institute, which dates back to 1903. The Pretoria National Botanical Garden opened to the public in 1984.

The aim of this Terms of Reference is to ensure that all professional quantity surveyors intending to quote, submit proposals based on the same understanding of the project.

2. Invitation to Quote

Quotations are hereby invited for the services of a professional quantity surveyor to assist SANBI for the various infrastructure interventions at the Pretoria National Botanical Garden.

2.1. Site Meeting and Briefing session

A compulsory briefing session for the services is to be held at the offices of the Pretoria National Botanical Garden at Environmental Education Centre at 11:00 on **20 February 2019**

2.2. Scope of Quantity Surveyor's Services

The quantity surveyor shall be required to review engineering design drawings from the appointed engineer and undertake a site investigation with the accompany of the appointed engineer to prepare a contract document ready for tender for the following infrastructure projects:

Project List:

- Completion of an incomplete retaining wall.
- Minor refurbishments to existing ablutions facilities.
- Concrete spalling repairs
- Flower bed construction
- Sliding gate at the garden entrance road including a gate support structure and electrical connections.
- Refurbishment of staff facilities.

3. PROJECT ADMINISTRATION

A close relationship between SANBI, their Programme Manager, appointed Engineer and the appointed quantity surveyor must be maintained during the preliminary phase of the project. One representative/project leader should liaise with SANBI (i.e. a single point of contact).

The leader shall ensure that the work undertaken complies with the scope of work described in this Terms of Reference. Should it become necessary to undertake additional work not described in this Terms of Reference, the work should not be undertaken until full motivation has been submitted to SANBI and approval for the work and the associated expenditure has been granted.

The project leader shall ensure that project staff regularly report back on progress made and on any findings. The project leader shall convey the information without any delay to the SANBI Project Manager or the appointed Programme Manager. If deemed necessary, a project management meeting will be arranged to discuss a way forward. SANBI reserves the right to cancel the contract if the above procedure is not adhered to.

3.1. DELIVERABLES

The quantity surveyor's documents shall be prepared according to acceptable standards as specified by SANBI's Programme Manager, Aurecon.

4. CONTENT OF PROJECT PROPOSALS

Invited quantity surveyors are required to submit, at their own cost, a separate Project Proposal, in which they demonstrate their understanding of the work to be undertaken and show their ability to perform the scope of works described in this brief.

Proposals should be concise and cost effective from a compilation and evaluation point of view. The following information, amongst others, needs to be included in the Proposal:

- a) A detailed description of the proposed methodology and deliverables.
- b) Audit team, if more than one individual: capability and availability.
- c) Project programme detailing all aspects of work to be undertaken and associated milestones and deliverables.
- d) Cost details for each of the deliverables, including specialist studies and anticipated disbursements.
- e) Details, qualifications and relevant experience of all team members, including the lead consultant.
- f) List of similar projects previously carried out with contact details of the client representative(s).

5. EVALUATION OF PROPOSALS

In accordance with the National Treasury Instruction Note on the Amended Guidelines in Respect of Bids that include Functionality as a Criterion for Evaluation (Issued 3 September 2010), this bid will be evaluated in two stages:

- 5.1. The first stage will evaluate functionality according to the criteria listed in the table below:

Service providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.

- 5.2. The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE Status Level Certificate.

Failure to submit the B-BBEE certificate/sworn affidavit mentioned above will not necessarily result in a bid being disqualified, but no points will be awarded for B-BBEE status.

Sufficient information must be provided to allow the Evaluation Panel to score bids against all these criteria.

5.3. Documents required:

- 5.3.1. Completed SBD forms (1, 4, 6.1, 8 and 9)
- 5.3.2. Central Supplier Database report – bidders must make sure that their Tax status is compliant, and information is updated
- 5.3.3. Service providers with one or more employees are required by law to contribute to the Compensation Fund. A valid letter of good standing certificate with COIDA is required. The certificate should be issued by the Department of Labour.
- 5.3.4. Proof of Public Liability Insurance.
- 5.3.5. An original or certified copy of B-BBEE certificate or sworn affidavit. (Please note that failure to submit a valid original or certified B-BBEE; certificate/sworn affidavit mentioned above will result in the tender not being awarded points.

6. INFORMATION TO BE PROVIDED BY SANBI

SANBI will cover the fee agreed upon with the appointed consultant.

SANBI staff members (SANBI's Principal Agent, SANBI's Chief Director: Conservation Gardens & Tourism and other delegated representatives) will avail themselves for various agreed meetings and will review and make comments on all draft documents as per the schedules agreed upon with the successful service provider.

7. Time Frames

The scope of work specified in this Terms of Reference must be completed within a 2-calendar month timeframe. A proposed programme for the required process must be provided in the proposal, including key milestones and deliverables.
