CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.

- 9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
 - 10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible

imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

TERMS OF REFERENCE

APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE ASSISTANCE WITH THE COMPILATION AND VERIFICATION OF THE GENERAL LEDGER AND TRIAL BALANCE FOR THE FINANCIAL YEAR ENDING 31 MARCH 2019

1. INTRODUCTION AND BACKGROUND

The South African National Biodiversity Institute (SANBI) derives its mandate from the National Environmental Management: Biodiversity Act (NEMBA), No. 10 of 2004. Chapter 1, Section 2 of NEMBA defines the following objectives:

- (a) To provide for the management and conservation of biological diversity within the Republic of South Africa and of the components of such biological diversity; the use of indigenous biological resources in a sustainable manner; and the fair and equivalent sharing among stakeholders of benefits arising from bioprospecting involving indigenous biological resources.
- (b) To give effect to ratified international agreements, relating to biodiversity, that are binding on the Republic.
- (c) To provide for co-operative governance in biodiversity management and conservation.
- (d) To provide for a South African National Biodiversity (SANBI) Institute to assist in achieving the objectives of this Act.

SANBI requires assistance with the compilation, review and verification of the general ledger and trial balance for the years ending 31 March 2019. Annual financial statements are to be produced in accordance with GRAP standards. The work will be undertaken at the two offices based in Pretoria and Cape Town.

2. SCOPE OF WORK

The scope of work will focus on the following at relevant business unit/s as identified:

- (a) Ensure that all accounting transactions (about 15 000 transactions) have been captured for the year to date (including opening balances) and then up till 31 March 2019;
- (b) Capture transactions that may be required;
- (c) Compile reconciliations of
 - Bank and cash balances
 - Receivables
 - Payables
 - Fixed assets
- (d) Compile analysis schedules of expenditure e.g. repairs and maintenance, payroll
- (e) Provide a Trial Balance at 31 March 2019 that will facilitate the seamless consolidation of the financial information into the annual financial statements of the SANBI;
- (f) Provide assurance that the transactions in the general ledger are valid, accurate and complete;
- (g) Review and recommend corrections to the general ledger expenditure accounts allocations (about 100 000 entries to be considered).
- (h) Provide the necessary lead schedules or file for audit purposes with supporting documentation.

4 REQUIREMENTS

The appointed Service Provider must have the following qualifications, extensive experience and sound track record in financial accounting, financial systems and auditing.

- Experience in working with the SAGE 300 ERP or similar systems;

- Extensive up to date knowledge and application of GRAP standards and experience in producing annual financial statements according to those standards.
- Identify key accounting issues and brings them to the attention of those charged with governance.
- Applies knowledge of current issues in audit, accounting, financial reporting standards, regulatory requirements and industry specific concerns where they may have an impact on the annual financial statements of the organisation.
- Provide their own necessary computer equipment during the assignment.
