CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.

1. Background

SANBI, as mandated by the National Environmental Management: Biodiversity Act, leads and coordinates research, and monitors and reports on the state of biodiversity in South Africa. The institute provides knowledge and information, gives planning and policy advice and pilots best-practice management models in partnership with relevant stakeholders with the aim of contributing to sustainable development through biodiversity conservation.

The Global Environment Facility (GEF) funded Biodiversity and Land Use Project, implemented by South African National Biodiversity Institute (SANBI) and its partners seeks to mitigate multiple threats to biodiversity by increasing the capabilities of authorities and land owners to regulate land use and manage biodiversity in threatened ecosystems at the municipal scale. The project aims to deliver a package of measures that will ensure future land use practices and permitting decisions do not compromise biodiversity and ecosystem function.

The project has a strong policy support and advice focus and to this end seeks to use of the NEM:BA Biodiversity Management Plan for Species (BMP-S) to improve management of medicinal plant species in Mpumalanga. Traditional medicine is understood to be widely used in South Africa; in both urban and rural communities. The harvesting and trading of medicinal plant species is having a significant impact on species being able to survive in the wild. Therefore to effectively improve the management of medicinal plant species, an understanding of both the ecological and socio-economic conditions affecting their use is necessary.

2. Objectives of the Consultancy

The overall aim is to develop a Biodiversity Management Plan, in accordance Section 43 of the National Environmental Management: Biodiversity Act (Act 10 of 2004) (NEM:BA) and the NEM:BA Norms and Standards for Biodiversity Management Plans for Species (BMP-S) for up to five species. However, to achieve this aim, assessments of the resource base and the impacts of resource extraction on these species is required. A service provider is therefore required to undertake a resource and extraction impacts assessment of the following species:

- *Bowiea volubilis*
- *Alepidea cordifolia*
- *Warburgia salutaris*
- *Dioscorea sylvatica*
- *Haworthiopsis limifolia*

3. Key activities to be undertaken

The resource assessment and extraction impacts assessment would entail conducting surveys in the field in order to undertake the following key activities:

- Determine and map the current distribution of the five species listed above (within Mpumalanga only);
- Undertake field surveys, the estimate and map the relative abundance/density of the species and population size structures within the Mpumalanga province;
- Determine what proportion of these species occur on privately owned land, on state land and in communal areas, and map this;

- Determine what proportion of these species' population occur in conservation areas, and map this;
- Determine the extent of harvesting for traditional medicine of these species;
- Document observed impacts of harvesting on the resource base and associated ecological systems, and map this across the range;
- Estimate the number of individual plants harvested annually;
- Determine the degree of sustainability of current harvesting and utilization; and the impact of current utilization levels on the integrity of the plant subpopulations across the province;
- Process and analyze the field data to provide a written report with maps.
- Design a monitoring programme to monitor and evaluate the trends in the resource base and harvesting impacts;

The field survey design should take into account the uneven distribution of plants within the province, landscape transformation and differing management systems in the landscape.

4. Deliverables and timeframes

The period of service will begin on 1 October 2019, or as close to this date as possible, for a period of eight months. Deliverables will be in the form of the following:

- A project inception report indicating the detailed work plan for the monitoring programme establishment and the assessment process, to be delivered two weeks after the signing of the agreement between SANBI and the consultancy;
- A report on an initial expert-based, rapid desktop survey is undertaken to clearly define the focus area or AOI for the study, including a suitable sampling and survey design, to be delivered six weeks after the signing of the agreement between SANBI and the consultancy;
- Draft monitoring plan (15 December 2019);
- Draft report on the assessment of the extent of the identified medicinal plant species, and the impact of harvesting on this base and associated ecological systems, based on analysis of field data. A measure of the degree of statistical certainty of the estimated resource size is required (15 March 2020);
- Final report on the assessment of the identified species as a resource and the impacts of resource extraction within Mpumalanga (30 April 2020);
- Detailed contact list of all stakeholder groups (30 April 2020);
- Baseline dataset and precise, repeatable methodology that allows for ongoing monitoring and assessment of the identified species as a resource, and its extraction, within South Africa (30 April 2020).

5. Minimum requirements of the service provider

The consultancy should have a multidisciplinary background, specifically with the following skills and competencies:

- Demonstrated understanding and experience of field resource surveys and resource extraction impacts;
- Skills in experimental design, statistical sampling, statistical analysis and GIS;

- Scientific report writing skills.

6. Requirements for quotation

The quotation must address the above-mentioned requirements and provide a concise proposal covering the scope of work, and must include:

- Details of the prospective service provider outlining relevant skills, expertise and track record.
- Details of at least three previous projects relevant to field resource surveys.
- Details of the proposed team, including relevant skills, experience and track record.
- CVs of team members.
- A report from a previous project.
- Three letters of reference.

Note that the quotation should include all anticipated travelling and subsistence expenses for the prospective service provider.

7. Quotation Evaluation Criteria

In accordance with the National Treasury Instruction Note on the Amended Guidelines in Respect of Bids that include Functionality as a Criterion for Evaluation (issued 3 September 2010), the quotations will be evaluated in two stages:

(b) A valid certified copy of BBBEE certificate or sworn affidavit. (Please note that failure to submit a valid certified B-BBEE certificate/sworn affidavit mentioned above will not necessarily result in a bid being disqualified, but no points will be awarded for B-BBEE status).

(c) Failure to attach the above documents will lead to your bid being disqualified.

The second stage will evaluate functionality according to the technical criteria listed in the table below:
