CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.

1. INTRODUCTION AND BACKGROUND

The Global Environment Facility (GEF) funded Biodiversity and Land Use Project, implemented by SANBI and its partners seeks to mitigate multiple threats to biodiversity by increasing the capabilities of authorities and land owners to regulate land use and manage biodiversity in threatened ecosystems at the municipal scale. The project aims to deliver a package of measures that will ensure future land use practices and environmental assessment decisions do not compromise biodiversity and ecosystem function.

A strong focus of the environmental management work programme of the Biodiversity and Land Use Project is to develop tools that will improve the mainstreaming of biodiversity into land use planning, assessment and decision making processes.

SANBI has developed Draft Thicket and Savanna Ecosystem Guidelines which will provide robust scientific information to assist stakeholders in considering biodiversity priorities in land use planning, environmental assessments and decision making. SANBI is satisfied with the technical content of the two guidelines but wants to procure the services of a writer to undertake a format review of the guidelines to deliver a concise product while ensuring that complex scientific information is presented in accessible language making it easier for both scientists and non-experts to utilize these guidelines.

2. OBJECTIVES OF CONSULTANCY

SANBI, through the Biodiversity and Land Use Project wishes to procure a Service Provider to undertake the following: -

- Undertake a format/layout review of the Draft Thicket and Savanna Ecosystem Guidelines
 - Undertake a format review and edit of the two guidelines to ensure that the documents are as concise as possible, that the information provided in these guidelines are user friendly, up to date, accessible and practical for implementation purposes including through infographics;
 - Source high resolution images to be utilized for the layout of the guidelines;
 - Provide final guidelines in a format appropriate for the SANBI appointed graphic designer to undertake layout (separate contract)

3. DELIVERABLES AND TIMEFRAMES
