The Department of Environment, Forestry & Fisheries (DEFF) has allocated R99 million over the 2019/20 – 2020/21 Medium Term Expenditure Framework (MTEF) towards a national infrastructure programme at the various campuses and sites of the South African National Biodiversity Institute (SANBI). The programme includes infrastructural maintenance, refurbishments, upgrades, replacements and/or new infrastructure at all sites. Terms of Reference

The proposed scope of work at the Harold Porter NBG, is as follows:

Attwel Bridge



Fig 1 – Fire damaged Attwel bridge

The Attwel Bridge spans approximately 7.2m and is about 1.56. Wide. The wooden bridge provided access to the eastern side of Leopards Kloof.

Round Bridge

The Round bridge spans approximately 9.2m and is about 1.2m wide. It provided access to the western side of Leopards Kloof towards Disa Kloof River. The bridge consisted of two large laminated wooden arch stringers to form the main elements of the bridge. These two elements are damaged in the fire beyond repairs and need to be replaced.

- The Service Provider is to design, supply and construct the Attwel bridge and Round bridge;
- Adhere to all SANBI's Health & Safety requirements as per the baseline H&S specifications provided;
- Provide the H&S file for approval as per the required specifications and scope of works;
- Inspect the site and burnt down bridges;
- Any survey or engineering investigations/designs e.g. geotechnical engineering etc. must be considered and priced by the Service Provider;
