CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

TO REQUEST THE REFURBISHING OF THE CURRENT RECEPTION AND FOYER AREAS OF THE NATIONAL HERBARIUM, PRETORIA

1. BACKGROUND AND MOTIVATION

The building of the National Herbarium was completed in 1972. Over the years very little was done in terms of the upkeep and refurbishing of the reception and foyer areas. Years of wear and tear is showing in the furniture, walls etc. Noise pollution from the adjacent kitchen and tea room area has become intolerable. The current reception area does not present itself as a professional area to receive visitors.

2. SCOPE OF WORK

The following will need to be attended to: please refer to the attached drawing, also see more details for measurements on the drawing:

1. Remove the glass panels and sliding doors that separate the Tea room and current foyer, including the louvre windows and solid glass windows above these panels and glass sliding doors. The removal also takes place around the corner as indicated.
Replace the glass panels, sliding doors and solid /louvres openings with double dry-walling up to the ceiling with insulation inserted between two layers for soundproofing.
Paint the dry walling with Velvagro Quicksand BBO317
2. Remove the glass panels and the glass sliding door with sliding track (3.1 m × 2 m) that separate the current reception area from the current foyer area (*see No 2 on drawing*)
Tile the floor areas where the sliding track was removed with a border pattern to match the rest of the tiles in the area, closely following the existing tile border pattern on the remainder of the reception floor.
3. Install the glass sliding door that was removed in No 2 and replace the glass panels and doors at the entrance of the current reception area with this sliding door. Secure the door on both sides within the frame so that they are closed and cannot be opened (*see no 3 on drawing*)
4. Install a dry wall or (2.5 m × 1.8 m), neatly finished on both sides in the reception area. This area should be 2.55 meters wide, measured from glass windows at the back towards front of current reception area

Paint the dry walling with Velvagro Quicksand BBO317 or equivalent.
5. Remove movable glass sliding door, sliding track and sliding mechanism with hanging brackets. (Leave the unmovable part of the sliding door). (*see No 5 on drawing*)

Tile the floor area where the sliding track was removed with a border pattern to match the rest of the tiles in the area, closely following the existing tile border pattern on the remainder of the reception floor.

6. Remove tiles and place a sunken welcome mat at the glass doors of the 'new' foyer on the inside. This should allow sufficient space for the doors to freely swing to the inside of the area. (see No 6 on drawing)

The broad scope of services required shall be in accordance with the relevant Board Notices providing the guideline scope of services and tariff fees for persons registered in terms of the Architectural Professions Act (Act No 44 of 2000) and others where applicable. If there is any conflict between the specific requirements and the relevant guideline scope of services document referred to above, the specific requirements shall take precedence.

3. COMPULSORY SITE MEETING AND BRIEFING SESSION

A site meeting and briefing session must be held in the National Herbarium to ensure that service providers are informed about the work requirements for this refurbishment.

4. COMPETENCIES REQUIRED

The services are to be delivered by a professional service provider with at least 10 (ten) years verifiable experience as a registered professional in the design and construction of similar projects.

Key Personnel

The service provider shall maintain the involvement of the key personnel as per the requirements of this contract. Should it become necessary to replace any of the key personnel listed in the proposal during the course of this contract, they may only be replaced by individuals with similar or better qualifications and experience, who satisfy the minimum requirements and then only with the approval of SANBI, the Employer.

5. REQUIREMENTS FOR PROPOSALS

Potential Service Providers are expected to produce the following documentation:

1. The service provider's profile and track record with respect to similar projects of this nature.
2. A concise written proposal that addresses the scope of work and the above requirements and outputs.
3. An abbreviated CV for each project team member indicating that person's relevance to the project and experience in carrying out a comparable assignment.
4. A detailed budget, including an estimate of the number of hours required to carry out the work, hourly rate and anticipated expenses. All proposals are to include VAT.
5. Occupational Health & Safety agent's cost to be included in final cost summary.
6. Three traceable references and contact details of clients from current or previous similar assignments.

6. EVALUATION OF PROPOSALS

The Preferential Procurement Policy Framework Act (No. 5 of 2000) and SANBI procurement process applies to these Terms of Reference. Note that Service Providers are required to comply with the processes outlined here and failure will result in the disqualification of proposals:
