CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.

TERMS OF REFERENCE

APPOINTMENT OF A PAINTING CONTRACTOR TO PAINT A PORTION OF PALISADE FENCE AT THE LOWVELD NATIONAL BOTANICAL GARDEN IN MBOMBELA

SANBI has been allocated funds by the national Department of Environment, Forestry & Fisheries (DEFF) for the period the period 2019/20 – 2021/22 for the refurbishment, upgrading, repair and maintenance of existing immovable infrastructure, vehicles and equipment as well as the construction of new infrastructure. The infrastructure will address the needs of SANBI from administrative, research, security and educational and tourism perspectives.

Projects have been identified for implementation over the MTEF at each of SANBI's existing campuses and sites across the country. The purpose of this tender is to procure a painting contractor for painting a portion of palisade fence at the Lowveld NBG, Mbombela.

Scope of Works

SANBI need to perform maintenance painting and related works on a portion of palisade fence at the Lowveld National Botanical Garden. The envisioned portion of fence is approximately 1,000m long, of which 520m is 1,2m high and the remainder 1,8m high.

The services to be provided under this contract include *inter alia*:

- Surfaces shall be thoroughly rubbed and cleaned down.
- Blistered or peeling paint shall be completely removed down to bare metal
- Sand old paint surface to a matt finish, feather edges and dust off.
- Remove surface contaminants using Polycell Sugar Soap (or approved equivalent) solution - 500 g Polycell Sugar Soap Powder (501703 or approved equivalent) dissolved in 5 litres water, or Polycell Sugar Soap Liquid (5018010 or approved equivalent).
- For stubborn contaminants use hot water in the above mix and a bristle broom or scrubbing brush.
- Rinse with tap water to remove all traces of sugar soap and allow to dry. Ensure surfaces are clean, dry and sound.
- Apply "Plascon Metalcare Metal WB Primer (MWP1 or approved equivalent)" to bare and repaired areas. Allow 16 hours to dry.
- Finish with two coats "Plascon Metalcare WB Enamel (WBE 1 or approved equivalent)" with 4 hours drying time between coats (Colour: SANBI Green, dye formula will be provided)
- The successful contractor is required furthermore to ensure that the application procedure/s of all materials, as specified by the manufacturer/s are adhered to and that all guarantees or warranties from said manufacturer, are supplied to the Implementing Agent at project close-out.

Extent of services

The services to be provided in terms of this project are inextricably linked to the Employer's three-year capital budget cycle. All services to be provided and painting works to be executed shall therefore be programmed to make full use of, but not exceed, the budget provision in any given financial year.

It should be noted that while the employer has every intention of completing the full Scope of Work making full use of the budget provision given, the Employer's budget is subject to periodic review. Should it become necessary to vary the scope of work or even suspend or terminate this contract, such variation, suspension or termination shall be dealt with in accordance with the provisions of the Standard Professional Services Contract.

The Service Provider is required to provide all aspects of the Service with reasonable care, diligence and skill in accordance with generally accepted professional techniques and standards, and ensure that all legal requirements are met, and that all legal processes are adhered to.

Key Personnel

The Service Provider shall maintain the involvement of the key personnel as per the requirements of this contract. Should it become necessary to replace any of the key personnel listed at the time of tender during the course of this contract, they may only be replaced by individuals with similar or better qualifications and experience, who satisfy the minimum requirements and then only with the approval of the Employer. The service provider shall ensure that the requisite number of personnel are continuously on site to complete the work within the allotted time of 40 working days.

Competencies and requirements

The successful Service Provider should possess the following skills, abilities & competencies:

- At least five years' verifiable experience as a painting contractor;
- Excellent knowledge, understanding and experience of outdoor painting of steel infrastructure and buildings;
- Excellent knowledge and understanding of the materials/tools available for painting as per the scope of works;
- Excellent knowledge of the life-cycle maintenance requirements of the affected infrastructure;
- Experience in the implementation of similar projects;
- Project and financial management experience and expertise;
- Excellent application skills; and
- Preferably, offices located in Mbombela

Evaluation process

** Service Providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE Status Level Certificate.
