1. BACKGROUND

The South African National Biodiversity Institute (SANBI) requires construction services at the Walter Sisulu National Botanical Garden (WSNBG). The Garden is located in a beautiful setting on the outskirts of Johannesburg. It is approximately 15km from Randburg and 25km from the center of Johannesburg, accessible from the N1 and arterial roads. The Ruimsig/Poortview area, in which the Garden is located, is one of the fastest developing up-market residential areas in Johannesburg, with the Garden being one of the fastest growing eco-tourism destinations in the Gauteng Province.

The South African National Biodiversity Institute (SANBI) requires the services of a suitably qualified and experienced contractor at the Walter Sisulu National Botanical Garden for the construction of new directional signage columns throughout the Garden. 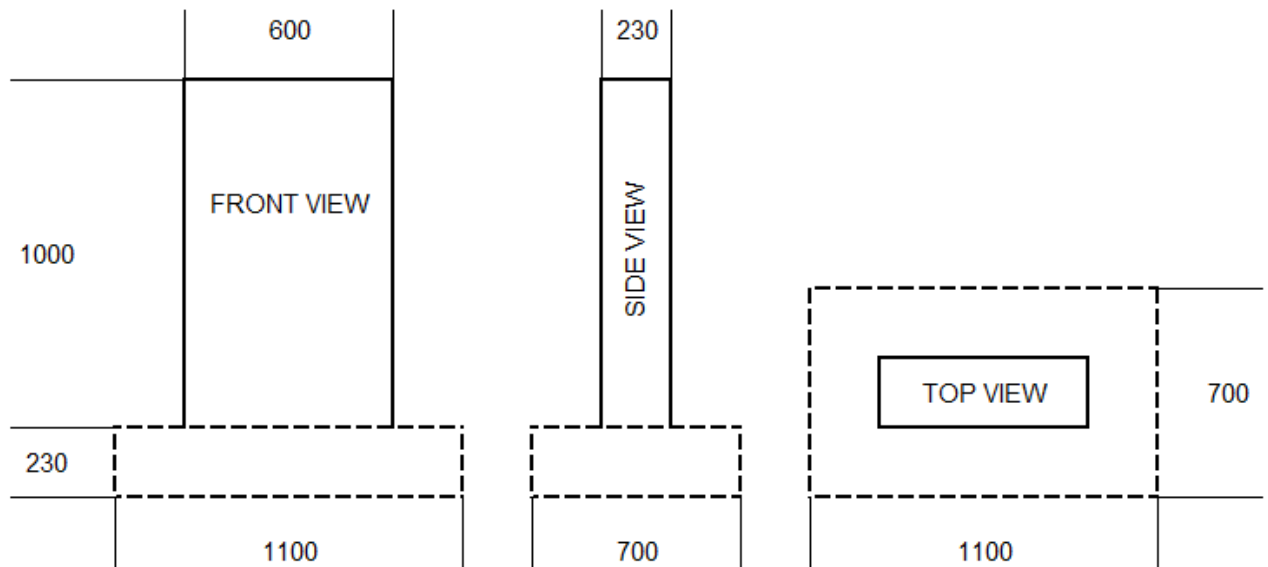
