CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all quotations¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

TERMS OF REFERENCE

APPOINTMENT OF AN OCCUPATIONAL HYGIENE SERVICE PROVIDER TO CONDUCT HYGIENE SURVEY AT SANBI'S CAMPUSES ACROSS SOUTH AFRICA

Purpose

The purpose of this request is to procure the services of an occupational hygienist to conduct hygiene survey at SANBI campuses across South Africa.

1. Background and motivation

According to Section 8 of Occupational health and safety Act no.85 of 1993 as well as Hazardous Chemical Substances Regulation 1995-Section 5, Lead Regulation of 2002- Section 6. Noise Induced hearing Loss Regulation of 2003- Section 6, Regulation for Hazardous Biological Agents of 2001- Section 6, all employers are required to perform an assessment of hazards that arise in their place of work that could results in the ill health of employees exposed to these hazards.

Furthermore employers are required to implement controls to mitigate these identified hazards and reduce their exposure to an acceptable level. The assessment is done by competent people

Scope of Works

An occupational hygiene survey is required to be conducted in SANBI in order to establish compliance with the requirements of the regulations of the Occupational Health and Safety Act (85 of 1993) that relates to lighting, noise, ventilation, heat stress and ergonomics, and to make recommendations where any non-conformances were identified

Extent of services

The services to be provided:

Lighting: The following need be verified

- Uniform illuminance.
- Optimal illuminance.
- Absence of reflections and glare.
- Adequate contrast.
- Correct colours.
- Absence of stroboscopic effect or intermittent light.

Noise: The following need to be verified

- The induction of permanent hearing damage.
- Masking of wanted sounds such as verbal communication.
- Interference with the nervous and cardiovascular systems.

Ventilation: The following need to be verified

- Provision of a continuous supply of fresh outside air.
- Maintenance of temperature and humidity at comfortable levels.
- Reduction of potential fire or explosion hazards.
- Response to airborne contaminants.

Heat Stress: The following need to be verified

- Externally imposed environmental heat
- Internally generated metabolic heat
- Exposure.

Ergonomics: The following need to be verified

- Awkward body postures such as maintaining an unnatural, unsupported or fixed posture such as bending, reaching or twisting for prolonged periods of time.
- Excessive repetition such as repeating the same motions over and over again.
- Excessive force, for example, physical exertion or pressure on any part of the body while lifting, pushing, pulling equipment or gripping a tool.
- Contact stress resulting from pressure by tools, edges or hard surfaces on soft tissues of the human body.
- Vibration from the operation of vibrating equipment.

The Service Provider is required to provide all aspects of the Service with reasonable care, diligence and skill in accordance with generally accepted professional techniques and standards and ensure that all legal and regulatory requirements are met, and that all legal processes are adhered to.

Key Personnel

The Service Provider shall maintain the involvement of the key personnel as per the requirements of this contract. Should it become necessary to replace any of the key personnel listed at the time of tender during this contract, they may only be replaced by individuals with similar or better qualifications and experience, who satisfy the minimum requirements and then only with the approval of the Employer. The service provider shall ensure that the requisite number of personnel are available to complete the work within the allotted time of 30 working days.

Competencies and requirements

The successful Service Provider should possess the following skills, abilities & competencies:

- At least five years' verifiable experience as an occupational hygienist;
- Excellent knowledge, understanding and experience with Hygiene surveys
- Experience in the implementation of similar projects;
- Excellent report writing skills;
- Project and financial management experience and expertise;
- Excellent application skills; and
- Preferably, a national footprint – impacts on pricing

Evaluation process

In accordance with the National Treasury Instruction Note on the Amended Guidelines in Respect of Bids that include Functionality as a Criterion for Evaluation (Issued 3 September 2010), this bid will be evaluated in two stages:

The first stage will evaluate functionality according to the criteria listed in the table below:

** Service Providers who fail to score a minimum of 70 points out of a possible 100 points on functionality criteria will not be eligible for further consideration.

The second stage will evaluate the price and preference points of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20 point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's B-BBEE Status Level Certificate.

Requirements for proposals

Service providers must submit a concise written proposal that addresses the scope of work and the above requirements and deliverables.

The following information needs to be included in the Proposal:

- A comprehensive description of the proposed approach, methodology and deliverables.
- Implementation team capability and availability.
- Project schedule, including aspects of work to be undertaken and associated milestones and deliverables.

Potential Service Providers should submit the following documentation:

- An electronic version of all reports must be submitted.
