- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.

**CERTIFICATE OF INDEPENDENT QUOTATION DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all quotations<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

**1. Background and overview of activities for which a service provider is required**

The Alien and Invasive Species (AIS) Lists and Regulations of the National Environmental Management: Biodiversity Act (NEM:BA; Act 10 of 2004) were first promulgated in October 2014. In March 2021, the amended AIS legislation came into effect. The AIS legislation provides the basis for regulating alien and invasive taxa in the country. SANBI seeks to appoint an independent service provider to collect and synthesise evidence for regulating alien and invasive plant taxa in the country. A framework to conduct risk analyses has been developed into the internationally accepted Risk Analysis for Alien Taxa (RAAT) framework (published in 2020) (<https://zenodo.org/record/4017196#.YDdP12gzY2w>). SANBI has also set up the Alien Species Risk Analysis Review Panel (ASRARP) to provide independent review and recommendations for regulating alien and invasive taxa in the country. The service provider will conduct 25 risk analyses on alien and invasive plant taxa and submit to SANBI for forwarding to ASRARP for independent review and recommendation.

The service provider is expected to:

1. Attend and pass a training course (five days part-time) on the RAAT framework provided by Stellenbosch University.
2. Develop 25 risk analyses on alien and invasive plant taxa using the RAAT framework.
3. Address comments from SANBI and ASRARP and revise the risk analyses accordingly.

**2. Minimum requirements of the service provider**

Those conducting the risk analyses should have:

1. Extensive experience in producing high-quality externally peer-reviewed scientific reports (e.g., journal articles in leading international journals) (a minimum of five publications).
2. Demonstrable knowledge with evidence on biological invasions and issues pertaining to the regulations and/or risks associated with alien and invasive taxa.
3. Excellent communication and writing skills, with attention to detail.
4. Own access to all relevant published scientific literature (i.e. journal articles and appropriate search engines).

Training to be supplied by SANBI:  
RAAT framework five-day part-time training course on-line.
