BACKGROUND

The South African National Biodiversity Institute (SANBI) requires services at Pretoria National Botanical Garden (PNBG). The garden is surrounded by urban development, offers a much-needed outdoor experience and wildlife in the eastern suburbs of Pretoria. The ridge that runs through the garden, the natural grassland and large lawned areas containing theme gardens of indigenous plants, which offer a habitat for our indigenous wildlife species.

INVITATION TO QUOTATION

Quotations are hereby invited for the appointment of a service provider to supply of flushable mobile toilet for the period of Twelve (12) Months at the Pretoria National Botanical Garden (PNBG). The quote process will be co-ordinated by SANBI's Supply Chain Management (SCM) Directorate at the following address:

REQUIREMENTS AND SPECIFICATIONS

The South African National Biodiversity Institute (SANBI) requires a Service Provider to supply and service of VIP flushable mobile toilets at the Pretoria National Botanical Garden for a period of Twelve (12) months.

Scope of Work

The scope of work is to Supply Two (2) VIP mobile toilet and 1 portable toilet on hire for the period of twelve months from July 2025 to June 2026 at the Pretoria National botanical Garden. Each Facility must be a dual VIP-Style toilet catering for both male and females separately. It must be waterborne and must contain its own refillable water tank for supply water.

SPECIFICATION:

- Hire of VIP toilets for the period of twelve (12) months from July 2025 until June 2026
- The toilet Units must be Full Flushing,
- The toilet must be serviced twice Per Week (Monday and Friday the service provider is required to submit the servicing letter to the garden office after servicing them).

4 Evaluation process

Evaluation Criteria will be base in two phases:

The second stage will evaluate the price and specific goals of those bids that meet the minimum threshold for functionality. In accordance with the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20-point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's specific goals.
