1. PURPOSE:

The purpose of this request is to procure the services of a service provider to conduct medical examinations for employees based at **Kwelera Natal National Botanical Garden, under the Forestry Greening Programme.**

2.BACKGROUND:

SECTION 8 of Occupational health and safety Act no. 85 of 1993 requires every employer to provide and maintain, as far as is reasonably practicable, a working environment that is safe and without risk to the health and safety of the employees. Medical examinations are done to assist with early detection, monitoring and management of adverse health effects of a particular work-related hazards. To achieve this SANBI must:

- Establish a planned programme of periodic examinations, which include clinical examination, biological monitoring, or medical tests of employees.
- The purpose of periodic medical examinations is for the early identification of conditions, if any, that could present an increased risk of adverse health effects related to the task being performed.
- Based on the type of work being performed, including consideration of factors such as the duration of the task, the materials being used, and the potential for exposure, medical surveillance is either recommended or required for the job.
- The employer should keep records of all medical examinations and control measures.

3.Scope of Works

The service provider is required to assist the SANBI to establish compliance with the requirements of the Occupational Health and Safety Act (85 of 1993).

- Do medical examinations which include the following:
 - Physical Examination including urine test.
 - Audiometric Screening Test.
 - Lung Function/ Spirometry Test.
 - Vision Screening.
 - Chest X-Ray.
- Medical examination to be done for approximately **5 employees.**
- The appointed service provider should have own equipment for conducting the tests. Mobile unit if based outside of **Kwelera.**
- The proposed time for the medical examinations is between **April 2025 and April 2026.**

3.1 Relevant Competencies and expertise

The Service Provider should possess the following skills, abilities & competencies:

- Knowledge, understanding and experience in Occupational Health.
- The personnel to be allocated this responsibility should be registered with South African Nursing Council or Health Professions Council of South Africa as a statutory body.

4.1 Other Requirements

- The Service Provider must provide a certificate of fitness upon completion of the medical examination.
- Referral of employees with identified abnormalities during medical examination.
- Provide a group report for the medical examinations done.

5. OPERATING HOURS

The appointed Service Provider will be required to provide services within the set time of the project, operating hours will be those that are set by the garden 08:00 to 16:00.

6. Evaluation process

In accordance with the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act (No.5 of 2000), this bid will be evaluated in 3 stages:

6.1 Administrative requirements – Compliance and Mandatory documents needed from bidders to submit. (Failure to submit the mandatory documentation WILL lead to disqualification of the bidder): **See table 1**

6.2 Price and Specific goals - In accordance with the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act (No. 5 of 2000), the 80/20-point system will be applied in evaluating proposals that qualify for further consideration, where price constitutes 80 points and a maximum of 20 points will be awarded based on the bidder's specific goals. **See table 2**
