1. BACKGROUND AND DISCUSSION

The Department of Forestry, Fisheries and the Environment (DFFE) has allocated funds over the 2025/26 to 2027/28 Medium Term Expenditure Framework (MTEF) towards a national infrastructure programme at the various campuses and sites of the SANBI. 5. KEY PERSONNEL

The service provider shall maintain the involvement of the key personnel as per the requirements of this contract. Should it become necessary to replace any of the key personnel listed at the time of tender during the course of this contract, they may only be replaced by individuals with similar or better qualifications and experience, who satisfy the minimum requirements and then only with the approval of the employer.

The involvement of the roles listed below, and reflected on SBD 3.3 Pricing Schedule, are not guaranteed and will be dependent on the scope of works and discretion of SANBI.

Appointment:

Contract and payment:
